

GENERAL TIGHTLINE OUTDOORS' TOURNAMENT AND EVENT RULES

Please see Fact Sheet for specific event regulations which might be different than these general rules per individual event regulations.

CHECK IN

See the Fact Sheet per event for specific times regarding off water times, rules meeting, and tournament hours.

FISHING LICENSES

All anglers must have a valid State Fishing License. Any and all taxes, fees and licenses are the responsibility of each angler.

PARK PASS

Entry fees for the event do not include or pay for entry into each park. Each vehicle coming into the Park must have a valid park pass.

STATE FISHING LAWS

All anglers must follow all State fishing laws for the lake. The tournament will follow and abide by all legal fishing methods for the lake where the tournament is held. All fish must be caught in a legal, sporting manner – on rod and reel. Spear fishing is not permitted.

BAIT

See Fact Sheet per Event.

WEIGH-IN

All fish must be weighed live. See Fact Sheet for specific tournament rules on limits per event. See Fact Sheet for penalties regarding dead fish. A fish that is not moving its gills at a normal rate is considered dead. NO CULLING is allowed at any of our events. Once anglers have reached their State and/or tournament specific limits they are done for the day and must proceed to weigh-in.

TOURNAMENT OFFICIALS AND STAFF

All decisions made by tournament officials and staff are final. This includes weigh-in. Please be respectful and courteous to the officials and staff. It is the intention of the officials and staff to promote good sportsmanship and fair play. Poor sportsmanship, cheating, or any type of foul play will result in immediate disqualification. All contestants and gear are subject to search for illegal bait or fish by tournament official and staff. All searches will be at random. Interpretation of these Rules & Regulations is at the discretion of the officials and staff. All decisions are final.

ALCOHOL

See Fact Sheet per Event.

DRUG USE

No drug use of any kind will be permitted during tournament hours.

REFUNDS

There will be no refunds of entry fees for any reason.

CONDITIONS & VENUE

In the event the location of the tournament needs to be changed, notice will be given up to 48 hours prior to the event start. In the event of unsafe conditions at the event venue, notice will be given up to one hour prior to the event for rescheduling or cancellation. There will be no refunds of any kind if the event is cancelled, rescheduled, or moved. Please see the Fact Sheet per Event for reschedule options.

CONTEST WINNERS

Payouts and prizes are based on a full field of anglers. See Fact Sheet per event to see the full field quota. Any and all taxes are the responsibility of the contestant. The names, likenesses, photos, and videos of the winning contestants may be used for future promotional purposes without permission from or compensation to the contestant.

WAIVER & RELEASE OF LIABILITY

By signing this Application all contestants agree to the following release of liability. In consideration of being permitted to participate in the Tightline Outdoors' tournament or event, the Applicant hereby releases Tightline Outdoors, its employees, tournament officials, tournament staff and volunteers, and others participating in the event, including all supporting and sponsoring companies, entities, and individuals, administrators and assigns from liability for any accident or injury that may occur as a result of our participation in the Tightline Outdoors tournament or event, whether by negligence or otherwise.
